**Mission: Keeping Consumer Safe**

**使命：保护消费者安全**

Vision: A nation free from unreasonable risks of injury and death from consumer products

CPSC is an independent federal regulatory agency formed in 1972 with a mission to protect the public against unreasonable risks of injury or death from consumer products through education, safety standards activities, regulation, and enforcement. 美国消费品安全委员会是美国联邦政府独立监管机构，成立于1972年，其使命是通过教育、安全标准活动、法规和执法来保护公众免受消费品造成的不合理受伤或死亡风险。

- Tracking information for children's products under 15 U.S.C. § 2063(a)(5):  
符合 15 USC § 2063(a)(5) 规定的儿童产品追踪信息:
- **Permanently affixed** to children's **product** and its **packaging**, if the nature of the product and packaging make it possible to do so in a way that can be read easily.  
如果产品性质和包装使其易于阅读，应将其永久附在儿童产品及其包装上。

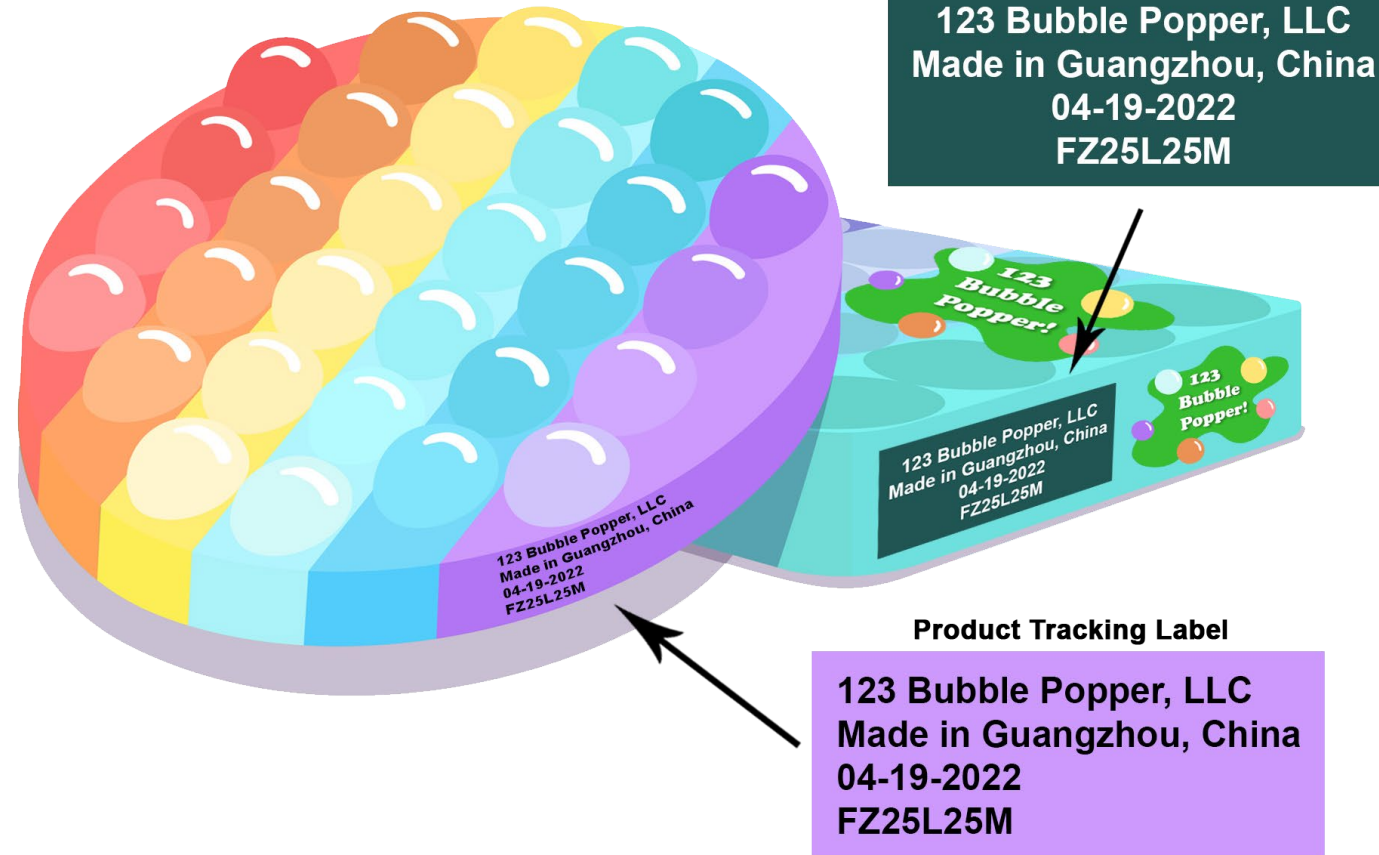

# Labeling: Choking Hazards

## 标签：气管堵塞危害

- Some toys and games that are or contain a small part, balloon, small ball, and/or marble **must be labeled** with a “choking hazard” cautionary statement per 16 CFR § 1500.19  
根据16 CFR § 1500.19 的规定，某些含有小部件、气球、小球和/或大理石  
的玩具和游戏必须贴有“气管堵塞危害”警示性陈述。
- Online warning label also required per 16 CFR § 1500.20  
根据16 CFR § 1500.20 的规定，还需要有网上警告标签
- **NOTE: Cautionary statements do not need third party testing.**  
注意：警示性陈述不需要第三方测试。





# Labeling: ASTM F963 Toy Standard

## 标签: ASTM F963 玩具标准

- The ASTM F963 Toy Standard (16 CFR part 1250), has very specific labeling requirements for some types of children's toys, such as aquatic toys, battery-operated toys, and stroller toys. ASTM F963 玩具标准（16 CFR part 1250）对某些类型的儿童玩具（例如水上玩具、电池驱动玩具和婴儿车上的玩具）有非常具体的标签要求。
- **NOTE:** Please note the updated version of the regulation, **ASTM F963-23** is effective for toys manufactured **AFTER** April 20, 2024. Children's toys manufactured before this date may comply with either ASTM F963-23 or ASTM F963-17.

# Labeling: Durable Infant or Toddler Products (16 CFR part 1130)

- **Durable infant or toddler products** must be permanently marked with:

  - The name of the domestic manufacturer or importer of record

# Registration Forms: Durable Infant or Toddler Products (16 CFR part 1130)

- Domestic manufacturers or importers of durable infant or toddler products must:

- Provide consumers with **postage-paid product registration form** attached to the product

- Provide consumers with option to register their product electronically (website or email)

- Maintain records of names, addresses, emails, and other contact info on consumers that register their products

# Federal Hazardous Substances Act (FHSA)

Hazardous substance defined as substance that is:

1. Toxic; corrosive; an irritant; a strong sensitizer; flammable or combustible; or generates pressure through decomposition, heat, or other means

2. May cause substantial injury or illness

# Federal Hazardous Substances Act (FHSA)

- Firms cannot rely on Globally Harmonized System (GHS) for FHSA requirements  
商家不能依赖全球统一制度 (GHS) 来满足 FHSA 要求
- Differing hazard classification and definition than FHSA  
与 FHSA 不同的危害分类和定义
- Dual labeling allowed  
允许双重标签
  - FHSA text must be kept together and separate from all other text  
FHSA文本必须放在一起并与所有其他文本分开
  - GHS label must not contradict FHSA label  
GHS标签不得与FHSA标签相矛盾

# Third Party Testing for Children's Products

## 儿童产品的第三方测试



- **Most children's products must be tested to applicable requirements at a third-party, CPSC-accepted laboratory:**  
大多数儿童产品必须在被**CPSC**接受的第三方实验室按照相应要求进行测试
  - Testing needs to be conducted on CPSC requirements: Testing to other country requirements (e.g., EN 71) does not meet U.S. requirements  
需要根据 CPSC 规定进行测试：符合其他国家/地区规定（例如EN 71）的测试不符合美国规定
  - For component part certification, or supplier conducted testing, the testing needs to have been conducted on representative samples of the exact component(s) or product(s) you will be importing or manufacturing  
对于零部件认证或供应商进行的测试，需要对你准备进口或制造的确切零部件或产品的代表性样品进行测试

# Third Party Testing for Children's Products

## 儿童产品的第三方测试



- **16 CFR § 1107.21** requires **periodic testing** for children's products that are in continuous manufacture. Periodic testing typically must be conducted annually in most situations.  
16 CFR § 1107.21 要求对持续生产的儿童产品进行**定期测试**。在大多数情况下，通常必须每年进行一次定期测试。
- If **material changes** are made to a children's product after initial certification, the finished product (or the component part that was changed) must be retested for compliance with those regulations affected by the material change.  
如果在初次认证后对儿童产品进行**材料更改**，则必须重新测试成品（或更改的零部件）是否符合受材料更改影响的法规。

### List of CPSC-Accepted Testing Laboratories

Section 14(a)(3)(E) of the Consumer Product Safety Act, as amended, requires the Commission to 'maintain on its Internet website an up-to-date list of entities that have been accredited to assess conformity with children's product safety rules.'

Third party testing is required to support a certification of compliance to the rules (shown at the bottom of the page) for children's products that are manufactured after the effective dates listed with each rule. The laboratories in this list have been accepted as accredited to test products to one or more of these children's product safety rules, as identified in the accreditation scope for each laboratory. A manufacturer of a children's product that must comply with one or more of these rules must support its certification of compliance with test results from one of these laboratories.

# Testing for General Use Products

## 普通用途产品测试

- General use products (non-children's products) subject to a CPSC regulation or standard may require testing  
需要遵守CPSC法规或标准的普通用途产品（非儿童产品）可能需要进行测试
- The use of a third-party, CPSC-accepted laboratory is **not** required for general use products  
普通用途产品**不需要**使用被CPSC接受的第三方实验室
  - First-party testing (in-house testing) or testing from any qualified laboratory or test facility are acceptable  
可接受第一方测试（内部测试）或任何合格实验室或测试机构的测试

# Certificates of Compliance

## 合规证书



- **Who is responsible for issuing a certificate?**  
谁负责颁发证书?
  - The domestic manufacturer or importer of a product subject to CPSC requirements is always legally responsible for issuing a **Children's Product Certificate (CPC)** or **General Certificate of Conformity (GCC)**, even if a third-party testing laboratory or another third party helps in drafting the CPC or GCC.  
需要遵守CPSC要求的产品美国国内制造商或进口商始终负有颁发**儿童产品证书 (CPC)** 或 **普通产品合规证书 (GCC)** 的法律责任，即使第三方测试实验室或其他第三方帮助起草儿童产品证书或普通产品证书。

# Certificates (CPCs/GCCs)

## 证书 (CPC/GCC)



- **Availability of Certificates:**

### 证书的有效性

- Must **accompany** each product or shipment covered by the certificate (“**accompany**” can include **electronic distribution**), including importation  
必须**随附**证书所涵盖的每个产品或货物（“**随附**”可以包括**电子分发**），包括进口
- Must be **furnished** to each distributor or retailer of the product (no requirement to provide to ultimate consumer)  
必须**提供给**产品的每个经销商或零售商（不要求提供给最终消费者）
- Must be **made available immediately (within 24 hours) upon request** to CPSC and U.S. Customs & Border Protection (CBP)  
必须根据CPSC和美国海关与边境保护局 (CBP) 的**要求立即 (24小时内) 提供**



# Certificates (CPCs/GCCs)

- **Requirements that do not need to appear in a CPC or GCC but with which compliance must still be ensured:**

  - Tracking information (required for all children's products)

  - Registration forms/cards (for durable infant or toddler products)

# Certificates (CPCs/GCCs)

- **Electronic Certificates:** the CPSC, by regulation, has confirmed that certificates in electronic form are acceptable; however, they:

  - Must be reasonably accessible by the CPSC

  - Must be created no later than time of shipment or first distribution within the United States per 16 CFR § 1110.13
