



## Alert from SafetyGate - analysis of risk products from China 安全门通报中国风险产品分析



In 2023, EU notified 1235 cases of risk products originating in China, accounting for 36.9% of the total number of risk products notified by EU Safety Gate.

2023年,欧盟通报产品原产地为中国的有1235例,占欧盟Safety Gate通报总数的36.9%。

The most frequently notified risk products originating in China were toys (31%).



#### Example of Chemical Risk 化学风险案例

Product 产品: Plastic doll 塑料玩偶

**Risk description** 风险描述: The doll head has an excessive amount of bis (2-ethylhexyl) phthalate (DEHP) (measured value: up to 12.3 % by weight). This phthalate may harm the health of children, possibly causing damage to the reproductive system. 玩偶头部含有过量的DEHP(测量值12.3%重量计)。该邻苯二甲酸酯对儿童健康有害,可损害生殖系统。

Alert reason 通报原因: The product does not comply with the REACH Regulation. 不符合REACH 法规要求

#### Example of Choking Risk 窒息风险案例

Product 产品: Rattle toy set 拨浪鼓玩具套装

**Risk description** 风险描述: The set of rattles has small parts. A small child could put them into the mouth and choke 套装含有小零件,小孩子可能将其放入口中导致窒息。

Alert reason 通报原因: The product does not comply with the requirements of the Toy Safety Directive nor with the European standard EN 71-1. 产品不符合玩具安全指令要求,也不符合EN 71-1.

## Example of Damage to hearing Risk 听力损伤风险案例

Product 产品: Toy telephone 玩具电话

**Risk description** 风险描述: The sound pressure level produced by the toy is too high (measured values: up to 81.1 dB), which could lead to permanent or partial hearing loss. 玩具产生的声压级过高(测量值:高达81.1 dB),可能导致永久性或部分听力丧失。

Alert reason 通报原因: The product does not comply with the requirements of the Toy Safety Directive nor with the European standard EN 71-1. 产品不符合玩具安全指令要求,也不符合EN 71-1.

Measures ordered by public authorities (to: Importer)监管机构采取的措施(对进口商): Withdrawal of the product from the market 从市场撤回产品







#### Example of Cut Risk 割伤风险案例

Product 产品: Plastic toy 塑料玩具

**Risk description** 风险描述: The dinosaur's tail has rough edges which can cause cuts to a child. 恐龙角有粗糙的边缘,会割伤小孩。

Alert reason 通报原因: The product does not comply with the requirements of the Toy Safety Directive nor with the European standard EN 71-1. 产品不符合玩具安全指令要求,也不符合EN 71-1.

Published on 发布日期: 24/03/2023

Measures ordered by public authorities (to: Importer)监管机构采取的措施 (对进口商): Import rejected at border 海关边境拒绝进口







#### Example of Burn Risk 燃烧风险案例

Product 产品: Children's fancy-dress mask儿童化装面具

**Risk description** 风险描述: The product is highly flammable. Children may wear the costume close to an ignition source and the costume may catch fire, resulting in burns. 产品高度易燃,儿童穿着的服装靠近点火源时,服装可能会着火,导致烧伤。

Alert reason 通报原因: The product does not comply with the requirements of the Toy Safety Directive nor with the European standards EN 71-1 and EN 71-2. 产品不符合玩具安全指令要求,也不符合EN 71-1和EN 71-2。




## Consequences of non-compliant products 问题产品的后果

- Adverse publicity in EU media press and TV 欧盟媒体负面报道-报纸以及电视
- Reputational damage 声誉损失
- Implications EU Importers and EU consumers 影响-欧盟进口商以及消费者

Indirect consequences – can be even more significant and impact EU and Chinese businesses 间接后果—可能更为严重,甚至影响到欧盟和中国之间的贸易


## Compliant process for placing products on market 产品投放市场合规流程

Understand the compliant requirement 了解合规要求

Prepare documents and carry out conformity assessment 准备文件,开展合格评定

Draw up a declaration of conformity, affix CE mark, affix labelling and marking, check for instructions

拟定EC合格声明,加贴CE标志,标识标签,说明书等









## Examples of materials and the chemicals (1) 材料及其可能含有的化学物质示例(1)

Soft plastics – PAH, phthalates

软塑料——多环芳烃、邻苯二甲酸酯

Rubber – zinc, PAH

橡胶——锌、多环芳烃

Textiles – formaldehyde, flame retardants, colouring agents

纺织品——甲醛、阻燃剂、着色剂

Leather – tanning substances e.g. chrome VI

皮革——鞣制剂,如六价铬







## Examples of materials and the chemicals (2) 材料及其可能含有的化学物质示例 (2)

Metal alloys – lead, iron, copper, mercury, zinc

合金——铅、铁、铜、汞、锌

Glass – lead, arsenic

玻璃——铅、砷

Wood – preservatives (chrome, arsenic, copper, creosote)

木材——防腐剂(铬、砷、铜、杂酚油)

Paper – colouring agents (heavy metals)

- Design reasonably 合理设计;
- Select material with discretion 谨慎选材;

#### Product marking requirements 产品标识清单

- Name and address of the manufacturer, or if the manufacturer is outside of the EU, the name and address of the manufacturer and the importer 制造商的名称和地址;如果制造商在欧盟之外,则要有制造商和进口商的名称和地址
- Type, batch, serial or model number 品类、批次、序列号或型号
- CE mark 玩具的CE标志
- Warnings 警告标识
